Nobody's Children Foundation awarded the prestigious European CSR Award Scheme for Partnerships, Innovation and Impact

Two online safety projects realized by Nobody's Children Foundation in cooperation with corporate partners: Orange Polska and Microsoft have been recognized in the Polish edition of the prestigious European CSR Award Scheme for Partnerships, Innovation and Impact.

The first Working Group on Child Participation was organized online on 10 April, 2013. The group will be chaired by Save the Children Denmark. Several members participated: Save the Children Italy, Obrela Greece, ECPAT Netherland, Kinderhilfe Germany, Save the Children Romania, ECPAT Austria, Happy Children Association-Turkey, NCBI Czech Republic.

Members discussed about the strategy to involve children in eNACSO activities taking into consideration their work at domestic level. Documents prepared during eNACSO I and II on child participation, minutes of the meeting and ToR have been sent to all eNACSO members.

eNACSO Events

6th Fundamental Rights Platform (FRP) Annual Meeting

eNACSO participated at the 6th Fundamental Rights Platform Annual Meeting from 24th to 26th of April in Vienna. The FRP is the Fundamental Rights Agency's (FRA) structure for cooperation and dialogue with civil society. The main purpose of the meeting was to foster and encourage a European debate on fundamental rights among different civil society organization, to facilitate knowledge and best practices among FRP participants and to create opportunities for networking and further cooperation with civil society, FRA and others. Particularly interesting in relation to the eNACSO current work on "the internet business model" was the meeting with the Data Protection and Privacy experts. eNACSO work on the issue was briefly presented and child protection and safety online was debated.

Forum of the ICT Coalition for a Safer Use of Connected Devices and online services by Children and Young People in the EU

The meeting aim was to update the members and Civil Society organizations on the state of play and progress of the ICT Coalition. Every member of the Coalition took a commitment during the past year to progress toward a better protection of online child rights. In order to monitor the progress to the achievement of these commitments an Honest Broker will be soon selected. The HB will probably be an academic, with a work background relating to both profit and non-profit sector. eNACSO is supervising the process and lobbying for a proper evaluation procedure.

What is the ICT Coalition? The ICT Coalition for the Safer Use of Connected Devices and Online Services by Children and Young People in the EU aims to help younger internet users across Europe to make the most of the online world and deal with any potential challenges and risks. The Coalition is made up of 25 companies from across the information and communications technology (ICT) sector. The companies are signatories to the principles, which aim to ensure that children and young people obtain the greatest benefit from new technologies, while avoiding the challenges and risks which are of concern to people worldwide. DG Connect - Industry and Awareness Strategies to make Internet Better for Children

DG Connect organized on April 16, this meeting with CEO Coalition members and third party stakeholders to discuss awareness raising techniques and to identify a set of collective best practices and actions.

DG Connect - Better Internet for Children - CEO Coalition

DG Connect organized this meeting on April 17, with CEO Coalition members and third party stakeholders as a follow up of the previous meeting in January to check on what has been done so far by the industries. Each member of the Coalition committed and issued a statement of purposes to improve their child safety initiatives. According to the updates given not much has been done so far but the majority of organizations represented were in the process of doing what they promised.

What is the CEO Coalition? The CEO "Coalition to make the Internet a better place for kids" has been launched On December 1, 2011 by the Vice President of the European Commission and Commissioner for the Digital Agenda. Its 30 members include among others Apple, Facebook, Orange, Google, Microsoft, Nintendo, Nokia, Samsung, etc. Its statement of purpose and working plan mentions five working areas: simple tools for users to report harmful content and contact, age-appropriate privacy settings, wider use of content classification, wider availability and use of parental controls and the effective take-down of child

abuse material.

MPFS - KIM Study 2012

Our partner Kinderhilfe informed us about the study series KIM (children + media, computer + internet) which has documented the media behavior of six- to 13-year-olds in Germany since 1999. For the first time the current KIM Study includes a special section “miniKIM” in which the media behaviour of two- to five-year-old children is described. Facebook for example is now the most favorite website of six- to 13-year-old kids despite the 13-years old limit for the registration. Check the English summary at [page 77](#).
