# INTRODUCTION TO SAVE THE CHILDREN

Save the Children is the world's leading independent organisation for children.

OUR VISION is a world in which every child attains the right to survival, protection, development and participation.

OUR MISSION is to inspire breakthroughs in the way the world treats children, and to achieve immediate and lasting change in their lives

Save the Children Italia (SC Italia) was created as an ONLUS in 1998 and is now a prominent member of Save the Children International.

## INTRODUCTION TO ENACSO PROJECT

SC Italia is the Network Coordinator of European NGO Alliance for Child Safety Online (eNASCO), a project which is currently funded by the European Commission under the Safer Internet Programme 2009-2013, a multiannual Community Programme on protecting children using the Internet and other communication technologies.

Since 2008 eNACSO has been promoting and supporting advocacy actions at national, European and international levels. Its work is based on the 1989 UN Convention on the Rights of the Child and its Optional Protocol on the sale of children, child prostitution and child pornography.

In the timeframe 2014-2016 the eNACSO project is in its final phase of EC funding.

SC Italia, on behalf of the 23 eNACSO Member organizations, is currently considering measures to promote the sustainability of the Network's activities in the future. This is important as the EC's financial support ends in 2016.

## JOB PURPOSE

The scope of this proposal is to engage a consultant able to provide assistance to eNACSO during its closing phase, specifically with regard to structuring it as an independent body.

### **RESPONSIBILITIES:**

The consultant's tasks and activities should lead to the achievement of the following outputs:

- Feasibility study. Conducting an initial benchmark analysis of the trends and most relevant statutes across Europe suitable for creating a new entity. This should identify a selected number of potential legal forms with a detailed description of each, to submit to the Board for sharing and approval. It should also identify the type of income generating business/activities eNACSO should be seeking/pursuing;
- **Business Plan**. Supporting the editing and fine-tuning of cost projections provided by the Secretariat and adjustment to the relevant new organization model;
- Assignment of a legal entity. Providing the necessary assistance to fulfill relevant legal requirements;
- Assistance to start-up stage. Carrying out tasks necessary to lead the organisation to adopt its chosen legal form, and assisting the staff in the launch of the start-up activities (i.e.: branding, registration of the trade mark, publicity, fiscal and legal requirements,....)

#### Others:

• To be collaborative with all other members of the team and to be focused on the objectives of the Project

- Experience with corporate restructuring.

### PRICING

SC Italia proposes to charge a fixed project fee between  $\notin$  5.400 and  $\notin$  5.850 for this work (single remuneration for the Consultancy) depending on the expertise of the applicant– excluding VAT (if applicable), travel and any other pre-approved expenses related to meeting key project milestones.

One third of this fee will be payable upon signing the contract, one-third will be paid upon assessment of the mid-term results (end April 2016), and the remainder upon completion of terms described under Responsibilities.
